Session Descriptions: Pre- Conference Sessions May 17

The Authority of the Court Officer - Knowing the legal foundation that supports court security officer's actions will empower them to provide legally compliant, safe, and consistent court service. During this course, faculty will define the statutory authority and powers given to Officers and court security officers to carry out their duties and obligations.

The Fundamentals of Courthouse Safety – Faculty will give an overview of the fundamentals required to ensure the safety and security of all who conduct business in the courthouse. The entertaining session will consist of photos from courts around Ohio and explanation of how the different problems pictured could be addressed.

Basic Weapon Handling – Officers in this course will review safety rules, stance, grip, muzzle control, trigger movement, basic range commands, required gear and much more. This course is intended for officers that have little to no experience or even experienced officers that would like a review of core fundamentals.

Weapon Retention - Weapon retention is arguably the most important factor in a close quarters fight. Losing control of your weapon is a worst-case scenario because it limits your ability to defend yourself and adds the potential of your own weapon being used against you. This course will provide hands-on practice in weapon retention skills.

Cuffing a Searching – Improperly applied restraints can cause injury to the individual (which may result in a lawsuit) or it can allow the individual to escape the restraints – neither of which are a desired result. This course will focus on how to safely approach an individual and effectively apply your handcuffs. Once a suspect is secured, you will want to search their person for weapons or cuff keys. Faculty in this course will demonstrate how to do this legally and safely.

Session Descriptions: Day 1 Conference Sessions, May 18

De-Escalation: Strategies for Best Possible Outcomes – National Trainer John Bostain will provide a three-hour session in the morning and afternoon on how to create situations where people can de-escalate themselves. He will talk about the **realities** of de-escalation, emotional intelligence and the range of integrated tactics and strategies to get the best possible outcome from a critical situation.

Basic Course of Fire – * During this three-hour course OPOTA certified firearms instructors will drill students to enhance the following skills: <u>accuracy</u> from various distances, <u>reloading</u> from multiple positions and while moving, moving and shooting, shooting around obstacles, and team work while shooting.

Session Descriptions: Day 2 Conference Sessions, May 19

Field and Officer Safety – Faculty in this session will review general considerations for officer safety and some of the things officers do that increase their risk. Some the areas covered will be safety mindset, your approach to a structure, stance, scanning for threats, complacency, crisis rehearsal, dealing with people and weapons of opportunity.

Advanced Course of Fire – * Building on the skills from the previous day, instructors will discuss working with vehicles including: a vehicle ballistics class, how to shoot into vehicles and how to shoot out of vehicles. Students will then spend the rest of the class practicing shooting into and out of vehicles.

*To participate in the live fire exercises on the range you must bring the following equipment:

- Firearm and duty gear, holster, 2 extra mags
- Bullet Proof Vest/Body Armor
- Ammunition at least 300 rounds
- Hearing Protection
- Eye Protection
- Head covering hat
- Balaclava face covering for glass from the vehicles
- Closed toed shoes
- Long sleeve shirt
- Gloves

He also held position as a Program Specialist in the Rural Policing Institute, Training Transformation Office, and Training Management.

In 2012, he became the recipient of the prestigious Trainer of the Year Award as selected by Law Officer Magazine. John is an Instructor Trainer (Core Instructor) for the Below 100 Program and is a member of the instructional staff of the BJA VALOR for Blue program. John is also an Advisory Board Member of the International Law Enforcement Educators and Trainer's Association (ILEETA)
