Hands-On Training, Pick 1

Break-Out 1: Basic Pocket Stick Operator (Max. 20 students)
Training on use of a low-profile less-lethal defensive and control tool to subdue assaultive and resistive subjects in the courtroom and other close-quarters environments. You will receive your own pocket stick.
